- 1. The statements in the application should be supported by an affidavit (Section C) made by the applicant before a Justice of the Peace or a Commissioner of Oaths.
- 2. There should be forwarded with the application any documentary evidence available to proved the facts set out therein, particularly those stated in Column II, 12(b) and 13(i) (b) and 13 < ii) (b) of Section B.
- 3. The application should be supported by two persons (Section D) each of whom must be:—
 - (a) intimately acquainted with and have a personal knowledge of the applicant's spouse and his or her family; and
 - (h) able from his personal know ledge and belief to vouch for the truth of the statements made by the applicant.
- 4. The applicant may be required by the Minister to supply such further information and proof as the Minister may think necessary.
- 5. The prescribed lee is payable before the issue of a certificate under section II.
- 6. Under Section 13 (2) of the Belizean Nationality Act. a person who is a citizen of any country other than Belize under any law in force in that country cannot be granted citizenship by registration unless he renounces citizenship of that country in accordance with that law.
- 7. A person who, for the purposes of procuring anything under this Act, makes any statement which he knows to be false in a material particular is guilty of an offence which is punishable with imprisonment for a term not exceeding twelve months.
- 8. The application should be sent to the Permanent Secretary. Ministry of Defence and Home Affairs. Belmopan.
